We are legal counsel to Nygård International Partnership and Peter Nygård.

We are writing to you in connection with the postings found at the URL set forth above. The content of the postings which have been broadcast on your website are extremely inflammatory, untrue and defame our client's reputation.

Be advised that this letter constitutes notice in writing pursuant to Section 14(1) of *The Defamation Act* (Manitoba) of the defamatory broadcast which would support an action for libel, the particulars of the libellous broadcast are found at the URL address above in the postings made under the names of "media", "newsman" and "Mackey".

We demand that you remove these libellous broadcasts from the website immediately, or alternatively, remove the website in its entirety. These posts are in violation of your own Terms of Use, which provide that:

 If it comes to DBP's attention that You are using DBP's services for purposes of engaging in, participating in, sponsoring or hiding Your involvement in, illegal or morally objectionable activities, including but not limited to, activities which are designed, intended to or otherwise:... (ii) defame, embarrass, harm, abuse, threaten, or harass third parties; (iii) violate state or federal laws of the United States and/or foreign territories... Further, our client is considering legal action against the posters using the website. We request that you provide us with all identifying information in your possession as to the registrant of the website and any and all posters. At the very least, this should include the registrant's names and address, IP addresses from which the postings were created, the user names and email addresses provided by the poster. As it is possible if not likely that the name and email addresses are not legitimate we request that you provide us with the IP addresses from which the posting was made. We request that the above requested information be provided to us within the next two business days.
